

**Terms and Conditions of Open Access publication funding in the Priority Research Area SciMat (hereinafter: SciMat PRA) under the strategic programme Excellence Initiative at Jagiellonian University**

These Terms and Conditions specify the general terms of awarding and receiving the funding of the costs of Open Access publications of research articles whose authors have named their affiliation as Jagiellonian University, in journals thematically related to the SciMat PRA.

1. Whenever these Terms and Conditions make reference to:
  - **open access** (Open Access – OA): it shall be understood as making available, free of financial, technology and legal barriers, research publications written owing to public funding, for use by researchers, students, entrepreneurs and society at large, adopting the Open Access Gold standard, which has the publisher of the article provide the open access;
  - **article**: it shall be understood as a research article, i.e. a reviewed article published in a scientific journal or in reviewed proceedings from an international conference:
    - 1) presenting a specific research problem in an original and creative manner, using a problem-specific or comprehensive approach,
    - 2) supplied with notes, literature references or other scholarly apparatus as appropriate for a given research discipline;
  - **author**: it shall be understood as an individual author of an article, a monograph or a chapter in a monograph, or – in the case of multiple authors – a correspondent author who represents their co-authors and acts as the person in the team responsible for communication with the journal or the publisher of the monograph at the time of submitting the manuscript, the review process, the publishing process, simultaneously ensuring that all requirements by the publisher of the journal or the monograph be met;
  - **article funding**: it shall be understood as covering the costs of publishing the article in the OA model, including the costs of publication and the publication fee;
  - **PRA**: it shall be understood as the Priority Research Area as specified in the Jagiellonian University's application in the "Excellence Initiative- Research University" competition, <https://id.uj.edu.pl/wniosek>);
  - **EI.JU**: it shall be understood as the Strategic Programme Excellence Initiative at Jagiellonian University implemented under the first competition announced in the communication by the Minister of Science and Higher Education under the programme 'Excellence Initiative– Research University.'
2. Funding to cover the costs of open-access publication of research and review articles in the SciMat PRA is granted to the best works published in relation to the strategic topics of the SciMat PRA (nanomaterials, materials related to energy generation and storage, materials used in biotechnology and medicine, new theoretical models supported by the advancement of information technology and algorithmics).
3. Funding pursuant to these Terms and Conditions may be granted to the author of an article dealing with the thematic area of the SciMat PRA, who has received positive reviews and confirmation from the publisher on acceptance for publication of research and review articles published in journals that on the list of scientific journals and peer-reviewed proceedings of international conferences of

- the Minister of Education and Science, valid on the date of submission of the application for article funding, have been assigned:
- a. 200 or 140 points, or
  - b. 100 points in the case of journals assigned to the disciplines: mathematics or computer sciences, provided that the AIS ratio for a given journal has the value of more than 0.9.
4. The condition for receiving funding is the compliance with the following requirements:
- a. The correspondent author must be an employee of one of the entities collaborating under the SciMat PRA at Jagiellonian University (correspondent co-author is equivalent).
  - b. State the affiliation of a Jagiellonian University entity as the first affiliation of the above-mentioned author in accordance with the applicable Order of the Jagiellonian University Rector on the mode of registration of publication achievements by employees, doctoral students and students of Jagiellonian University and indicating the name of Jagiellonian University when stating the publication's affiliation.
  - c. Provide a note on obtaining positive reviews and final acceptance of the article for publication by the journal editor (confirmation from the publisher of accepting the article for publication in the journal) in the proposal form.
  - d. Declare in the proposal form the inability to fund open access to the article in the Open Access Publishing Programs of the Virtual Library of Science.
5. In order to apply for funding, 'Open Science SciMat Form' must be completed at [strefa.id.uj](http://strefa.id.uj). The proposal shall be supported with a copy of the article. Submitting the form is tantamount to the acceptance of these Terms and Conditions, including making oneself familiar with the Annex concerning personal data processing.
6. Proposals are submitted in a continuous call. The call is concluded once the resources allocated in the budget for a given calendar year have been exhausted. In the case of increasing the pool of funding, the call may be re-opened.
7. The decision on funding shall be issued within 5 business days, to ensure proper payment processing.
8. The authors may not apply for similar support with other PRAs active at JU over the entire course of proposal evaluation in the SciMat PRA.
9. The author who receives the funding shall:
- a. Include an appropriate note in the acknowledgements sections on the funding received under the EI.JU programme in Polish or in English, and information on the participation of the research team / JU in the strategic Programme Excellence Initiative at JU:

- b. Submit a declaration referred to in Article 265, clause 13 of the Act of 20 July 2018, Law on higher education and science (i.e. Journal of Laws of 2021, item 478 as amended) authorising the Jagiellonian University to

include the article or monograph among the achievements in the discipline or one of the disciplines to be indicated in a declaration referred to in Article 343, clauses 7 and 8 of the above mentioned act as the discipline(s) they represent.

- c. Deposit the full text of the publication to the Jagiellonian University Repository, following its release.
10. An open-access model funding proposal may be submitted only by the corresponding author of a given publication (corresponding co-author is equivalent).
11. The maximum amount of funding, which should be understood as covering the costs of publishing an article in the open access mode, including the costs of publication and the publication fee, which can be applied for at one time, is PLN 20,000. In particularly justified cases, taking into account the outstanding science of the submitted publication and the prestige of the journal, funding in excess of PLN 20 000 may be granted.

Annex to the Terms and Conditions of Open Access publication funding in the Priority Research Area SciMat under the Strategic Programme Excellence Initiative at the Jagiellonian University

### Information on Personal Data Processing

Pursuant to Article 13 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter: GDPR), the Jagiellonian University informs that:

1. the Controller of your personal data is the Jagiellonian University, with a registered seat at ul. Gołębia 24, 31-007 Kraków, represented by the JU Rector.
2. The Jagiellonian University has appointed a Data Protection Officer at ul. Czapskich 4, 31-110 Krakow, room no 27. The DPO can be contacted via e-mail at [iod@uj.edu.pl](mailto:iod@uj.edu.pl) by phone at 12 663 12 25, from Monday to Friday between 8 a.m. and 3 p.m.
3. Your personal data provided in the call entry will be processed:
  - a. In the case of all Participants – for the purpose of launching and operating the Call pursuant to the Terms and Conditions of Open Access publication funding in the Priority Research Area SciMat under the Strategic Programme Excellence Initiative at Jagiellonian University (hereinafter: the Call) pursuant to Article 6.1.f of the GDPR, i.e. for the purposes of the legitimate interests pursued by the controller, which consists in naming the laureate of the Call;
  - b. in the case of a Participant awarded funding in the Call: for the purpose of legal obligations imposed on the Call's Host, including in particular the tax obligations, including in particular pursuant to Article 6.1.c of the GDPR.
4. While providing your personal data is voluntary, it is a necessary prerequisite for taking part in the Call. Not providing personal data precludes participation in the Call. In the case of Participants referred to under point 3.b above, providing the data constitutes a legal obligation, and failing to provide them shall preclude awarding the Participant.
5. Personal data of the Participants referred to under point 3.a will not be made available to entities outside the Call Host Entity's staff.
6. Personal data of the Participants referred to under point 3.b above, may be published on the Call Host Entity's website, and they may be published in its social media. These data will also be made available to authorised public authorities, including, in particular, to the extent that these authorities are authorised to verify the fulfilment of the legal obligations imposed on the Call's Host.
7. Your personal data shall not be transferred to third countries (outside the EEA) / to international organisations.
8. Personal data of the Participants referred to under point 3.a above shall be processed until the Call is concluded and its results made known. Personal data of the Participants referred to under point 3.b above shall be processed in the period resulting from fiscal regulations, and subsequently, for archiving purposes, pursuant to applicable legal regulations.
9. You have the following rights: to obtain information on personal data processing and rights resulting from the GDPR, to access your data and rectify them, as well as to have them deleted from the controller's database (unless further processing is necessary for fulfilling a legal obligation or for the purposes of determining, pursuing, or defending claims), to limit their processing or transfer, and to object

to the processing of the data – in the cases and under the conditions specified in the GDPR.

10. Your personal data will not be subject to automated decision making or profiling.
11. You have the right to lodge a complaint with the President of the Office for Personal Data Protection, should you ascertain that the processing of your personal data violates the provisions of the GDPR.
