which will be held

26–27 September 2024 in Kraków, Poland.

‘Converging Realms: Law, Technology, and Society in the Age of Ethical and Multi-Agent AI’ is an international conference that brings together scholars, practitioners, civil society and policymakers from around Europe to explore the ethical questions, practical challenges and opportunities surrounding artificial intelligence.

The conference will be devoted to various interactions between AI and ethics, culture, justice, privacy, research and education. Topics of interest include, but are not limited to:

- ethical AI; principles, guidelines and legal regulations for ethical AI;
- personal data security & AI, privacy in an AI-dominated future, AI privacy protection strategies;
- AI & justice system, legal liability for/of AI, AI & social justice principles;
- AI technologies in culture and in the creative sectors;
- gen-AI in research; open-source AI research, AI vs. scholars;
- AI and critical thinking, AI in educational process, AI and disinformation.

Active participation may take the form of a poster (other forms may be discussed via email with the organizers). We welcome submissions from students, PhD students and post-docs, researchers as well as people or institutions from outside academia

Poster session will be held during the regular conference days, with dedicated time-slots, i.e., there will not be any parallel sessions to it.

- abstracts of posters (no more than 3000 characters including spaces)

- decision: 10 August 2024

Review process:

That is why we will be using a double-blind review process to evaluate all submissions.
